<u>REAL GOOD TECHNOLOGIES, LLC'S</u> NOTICE CONCERNING PENDING MOTIONS

Real Good Technologies, LLC respectfully submits the following notice

concerning its position on the status of pending motions, and states as follows:

Motion for Revestment (ECF No. 146)

1. On July 8, 2019, Real Good Technologies filed a Motion Seeking an Order Compelling Victory Solutions to Return Certain Property That has Been Revested Under 11 U.S.C. § 349(b)(3). (ECF No. 146). Victory Solutions filed an opposition brief objecting to the motion for revestment. (ECF No. 149). Real Good filed its reply on July 31, 2019. (ECF No. 150).

2. On August 12, 2019, this Court issued an Order requiring Victory Solutions to file an inventory by August 19, 2019. (ECF No. 152). Victory Solutions failed to timely comply with the Court's Order and Real Good subsequently filed a show cause motion on September 3, 2019. (ECF No. 153).

3. On the eve of the scheduled show cause hearing, Victory Solutions filed a Notice of Filing of Location of Equipment. (ECF No. 155).

4. Victory Solutions' notice indicates that some of the property subject to automatic revestment under 11 U.S.C. § 349(b)(3). (ECF No. 155, Ex. A).

5. Real Good takes the position that its motion for revestment is ripe for the Court to rule on, subject to the Internal Revenue Service's position should they seek to intervene in this matter.

6. Real Good Technologies has voluntarily added the address listed for the Internal Revenue Service in the recently dismissed Chapter 11 proceedings to the Certificate of Service below:

Equipment (ECF No. 155), albeit late and in the face of a show cause order, Real

Good withdraws its motion to show cause. Real Good expects to seek confirmatory

discovery on the nature and whereabouts of the property in question.
