To be sure, Real Good Technologies sets forth a chronology of Victory Solution's Bankruptcy Case. Victory Solutions has no quibble with Real Good Technologies' legal authorities. What Real Good Technologies fails to explain is what Real Good Technologies is entitled to have re-vested. It is undisputed that Real Good Technologies' interest, whatever it is, is secondary to the IRS so, truly, Real Good Technologies has no interest in this equipment. Revesting, under the Bankruptcy Code is not much different than a Quit Claim Deed; Real Good Technologies can only be re-vested with what it has, which is an interest secondary to the Internal Revenue Service. The interest of the Internal Revenue Service takes out all of the equity in all of the equipment of Victory Solutions. Therefore, Real Good Technologies in entitled to nothing. Interestingly, Real Good Technologies did not respond to Victory Solutions' criticism of the cases relied upon by the Magistrate Judge. As set forth in Victory Solutions' prior pleadings, those cases are inapposite and should not have been relied upon by the Magistrate Judge. Finally, the suggestion that the IRS is not interested in Victory solutions is misplaced. The Service has filed a new lien in an amount of over \$45,000 as of November 22, 2019.
