**SMALL BUSINESS COUNCIL OF AMERICA
HONORS MEMBERS OF CONGRESS AND SMALL BUSINESS OWNERS DURING
35TH ANNUAL PUBLIC AFFAIRS DAY AND CONGRESSIONAL AWARDS RECEPTION**

WASHINGTON, D.C. (May 10, 2018) – On May 9, 2018, the Small Business Council of America (SBCA) held its 35th Annual Public Affairs Day and Congressional Awards Reception in Washington, D.C. The SBCA is a national non-partisan nonprofit organization which represents the interests of more than 100,000 privately-held and family-owned organizations on federal tax, employee benefit and health care issues.

The Public Affairs Day and Congressional Awards Reception featured remarks and presentations from members of Congress, congressional staff members, and a political reporter, discussions about the critical issues facing small businesses, and the presentation of the SBCA's annual awards.

During the Public Affairs Day, the SBCA presented the following awards:

Senator Bob Casey (D-PA) was awarded the SBCA's Congressional Award for his commitment to small business issues and his efforts to help protect the retirement security of all Americans as a member of the Senate Finance and Health Education, Labor and Pensions Committees and the Senate's Special Committee on Aging.

Senator Tim Scott (R-SC) was awarded the SBCA's Congressional Award for the first hand understanding that he has brought to small business issues and his commitment to ensuring that Congress does not lose sight of the importance or needs of the country's small businesses.

Following the conclusion of Public Affairs Day, the SBCA presented the following awards during its Congressional Awards Reception:

Congressman Richard Neal (D-MA) received the Special Congressional Appreciation Award in recognition of his tireless efforts on behalf of small businesses as Ranking Member of the House Ways and Means Committee, including his recent letter to the IRS regarding the significant increase in VCP user fees for small businesses. Congressman Neal was previously recognized with the SBCA's Congressional Award.

Mr. and Mrs. Hale were honored for their work as co-owners of Ability Production, LLC, a spinal cord injury design and consulting nonprofit founded in 2004 which provides services, information and resources for individuals managing spinal cord injuries. Thanks to the generous contributions of the SBCA, SBCA Director Neil Carrey and his wife, Karen Carrey, and many SBCA members, the SBCA was able to present Ability Production with a significant contribution from the Chris Carrey Charitable Foundation.



The SBCA's Mort Harris Small Business Person of the Year Award was presented to **Becca Riker**, of Cleveland, Ohio. Ms. Riker is the owner of The Mutt Hutt, which is a cage-free canine care center in Cleveland, Ohio. In conjunction with the Mutt Hutt, Ms. Riker also runs Second Hand Mutts which is a non-profit animal rescue. The award was presented to Ms. Riker by SBCA Board Member, Christy Woskobochnik.
