

# Telephone Consumer Protection Act (TCPA)

Bailey Glasser has served as lead counsel in class action lawsuits generating almost \$150 million for consumers harmed by companies that violate the Telephone Consumer Protection Act (TCPA). This law protects consumers from unsolicited telemarketing calls, robocalls, and spam text messaging on home and cellular telephone lines. Every time the TCPA is breached without penalty it erodes the privacy of individuals.

Notably, Bailey Glasser scored a precedent-setting TCPA win of a jury verdict and treble damages award resulting in a \$61.3 million class action judgment for against DISH Network. The firm was lead trial and appellate counsel, and the judgment was completely affirmed by the US Court of Appeals for the Fourth Circuit.

On the heels of the DISH verdict in 2017 came two more TCPA class action settlements for our clients - one against Alarm.com for \$28 million, and another against Monitronics International, also for \$28 million.
