## Representative Matters

- Served on the science and technology committee of the Plaintiffs' Steering Committee in the Volkswagen "*Clean Diesel*" Marketing, Sales Practices, and Products Liability Litigation MDL before the US District Court for the Northern District of California; reached the largest automotive class action settlement in history with a value to consumers of over \$11 billion, requiring VW to buy back nearly 500,000 vehicles and offer emissions-compliant fixes to other vehicles with additional cash payments
- Worked on the PSC's science and tech committee in the Chrysler-Dodge-Jeep EcoDiesel Marketing, Sales Practices, and Products Liability Litigation MDL; resulted in settlement in excess of \$300

million and required Chrysler to complete modifications of class vehicles to improve their emissions

F-150 and Ranger Truck Fuel Economy Marketing and Sales Practices Litigation* MDL before the US District Court for the Eastern District of Michigan based on Ford's misrepresentation of the fuel efficiency of certain pickup trucks
